

The Johnsburg Community Club, Inc.

Application for Membership - 2008

Regular Membership

Individuals over age 21. May hold elected office and may vote to remove officials for cause. Must reside within the geographic limits of Johnsburg School District or the Village Boundaries. Have full voting privileges (by mail, in person, or by proxy). Has the right to vote on amendments to by-laws and a resolution to dissolve the corporation.

Associate Membership

Individuals over the age 21. Have full voting privileges, as above except for removing officials and other members. May not hold elective office but can chair committees that influence club direction. Resides outside of the geographic limits of Johnsburg School District or the Village Boundaries. (Must be sponsored by two Regular Members).

Regular Family Membership

Includes all family members over age 21 who reside at the same residence within the geographic limits of Johnsburg School District or the Village boundaries. (One vote per family in balloted elections and resolutions, but full voting privileges)

Associate Family Membership

Includes all family members over age 21 who reside at the same residence outside of the geographic limits of Johnsburg School District or the Village boundaries. Must be sponsored by two Regular Members. (One vote per family in balloted elections and on resolutions but restricted as Associate members are above).
